Motion made by Commissioner Greer, seconded by Commissioner Gray, that the following Resolution be and the same is hereby adopted, to-wit:

## RESOLUTION

WHEREAS, it being the desire of County Commissioner, Claude Bailey, to have detached territory hereinafter described, from Commissioner's District No. 2, and to attach said territory to Commissioner's District No. 3, which territory embodies the territory described on the Election Precinct areas known as Election Precincts 95, 96, 97 and 106; 91 and 93;

THEREFORE, BE IT RESOLVED by the Board of County Commissioners that there be detached from Commissioners District No. 2 and attached to Commissioner's District No. 3, the following described territory in Tulsa County, Oklahoma:

Beginning at a point designated as the intersection of 13th Place and the Midland Valley Railroad, and proceeding in a Southwestern-Southeastern direction along said Railroad to Hazel Boulevard, thence West along Hazel Boulevard to the east bank of the Arkansas River, thence continuing along the eastern bank of said River, in a North-Northwestern direction to the intersection of 15th Street and the eastern bank of the Arkansas River, thence due east on 15th Street to the intersection of 15th Street and Elwood, thence North along Elwood to the intersection of Elwood and 13th Street, thence east along 13th Street to the intersection of 13th Street and Cheyenne Avenue, thence north along Cheyenne Avenue to the intersection of 12th Street and Cheyenne Avenue, thence east along 12th Street to the intersection of 12th Street and Main Street, thence south along Main Street to the intersection of Main Street and 13th Place, thence east along 13th Place to themintersection of 12th Place and Detroit Avenue, thence South along Detroit Avenue to the continuation of 13th Place, thence east along 13th Place to the Midland Valley Railroad and the point of beginning.

thus embodying all that territory which now embraces Election Precincts 95, 96, 97 and 103, 91 and 93, and that the boundaries of Commissioner Districts No. 2 and No. 3 is hereby altered accordingly.
