Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 2:00 o'clock P. M. with the following members present: J. B. Gray, Chairman; Curtis Greer and Claude W. Bailey, Members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the application for additional and supplemental appropriation for the County Highway Cash Fund in the amount of \$10,952.09 be and the same is hereby approved and the Chairman is authorized to sign same and submit it to the Excise Board for their consideration. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the Cash Fund Estimate of Needs and request for Appropriation to the County Highway Restricted Cash Fund in the sum of \$4,321.48, be and the same is hereby approved and the Chairman is authorized to sign same and submit it to the Excise Board for their consideration. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the following Contract for Architectural Services by and between Leon B. Senter, A.I. A., Tulsa, Oklahoma, and the Board of County Commissioners, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

CONTRACT FOR ARCHITECTURAL SERVICES

1. THIS AGREEMENT, made and entered into this 16th day of April, 1946, by and between Leon B. Senter, A. I. A., of Tulsa, Oklahoma, as Party of the First Part, and hereinafter called the ARCHITECT, and the County Commissioners in and for Tulsa County, State of Oklahoma, as Party of the Second Part and hereinafter called the OWNER.
2. WITNESSETH: (a) That the ARCHITECT herein proposes and agrees to furnish for the OWNER, full and complete architectural services for the following work to be done in connection with the separate schools of Tulsa, Oklahoma.

Two (2) standard class rooms, addition to Dunbar School  
One (1) crafts and shops class room, addition to Carver School  
One (1) auditorium, addition to Carver School (seating approximately 700).  
One (1) cafeteria addition to Dunbar school.  
Central heating system for Dunbar school.  
Central heating system for Booker T. Washington School.

(b) The architectural services shall consist of the necessary conferences with the OWNER, the preparation of preliminary plans and studies, complete working drawings, specifications, large scale and full size detailed drawings, the drafting of forms of proposals and contracts, the issuance of certificates of payment to the contractors and the general supervision of the work.

(c) The architectural services to further include complete engineering services for all branches of the work such as heating, ventilating, plumbing and drainage, and electrical and structural engineering.
