## CONTRACT

This contract and agreement made and entered into on this the 19th day of April, 1946, by and between the Board of County Commissioners in and for Tulsa County, Oklahoma, and Thlsa County Drainage District No. 13 of said County as parties of the first part and Wood and Craig, Engineers, a form composed of Eugene N. Wood and Allan Craig of Tulsa, Oklahoma, parties of the second part; witnesseth that:

WHEREAS, parties of the first part have this day employed parties of the second part as Engineers for Tulsa County Drainage District No. 13, commonly known as the Jenks Levee District, to perform all engineering services in connection with the determination of damages and assessments, the acquisition of easements and rights-of-wayand the preparation of ownership and property line maps.

THIS AGREEMENT WITNESSETH, that it is agreed between the parties hereto that the Board of County Commissioners and Drainage District No. 13, Tulsa County, Oklahoma, will pay Wood and Craig, for the engineering services above outlined, a fee of five(5%) percent of the total cost of the District of acquiring the rights-of-way and for easements necessary for the construction of the proposed levee and related structures and all other costs to the County and/or District in connection therewith, excepting legal fees, appraisal fees, advertising and printing costs; said fee however, in no event less than Twenty-Five Hundred Dollars (\$2500.00).

AND IT IS FURTHER situplated and agreed that said fee is to be paid as follows to-wit: TwelveHundred Fifty Dollars (\$1250.00) when funds of said Tulsa County Drainage District No 13 have been made available therefor; the balance and remainder of said fee to be paid at intervals as the said project progresses from time to time upon written application therefore, approved by the County Engineer.

HOWEVER, it is further agreed and understood between said parties that the last partial payment on said fee shall not be paid until said Project has been completed and accepted by said Board of County Commissioners and said Drainage District.

IN WITNESS WHEREOF, The Board of County Commissioners have caused this instrument to be executed in quadruplicate and attested by the County Clerk with his official seal and signature, and the second parties execute same by their signatures and all parties acknowledge the receipt of a copy of same.
