AGREEMENT

THIS AGREEMENT, made this 6th day of May, 1946, by and between Tulsa County, Oklahoma, (hereinafter designated as Owner), thru it's legally authorized representatives The Board of County Commissioners, and Jos. P. Koberling, A. I. A., licensed Architect of Tulsa, Oklahoma, (Herinafter designated as Architect):

WITNESSETH: That the Architect, in consideration of the agreement herein made with the Owner, agrees with the said Owner, as follows:

The Architect will provide all preliminary plans required to outline Recreation Facilities and a Garage Building for Separate Negro Schools in Sand Springs, Oklahoma, to the Owner, and will also assist the Owner, if required, in the preparation of proper application forms for presentation to any priority boards involved for premission to build the project.
