AGREEMENT BY COUNTY TO MAINTAIN HIGHWAYS IMPROVED UNDER PROVISIONS OF FEDERAL HIGHWAY ACT AS AMENDED AND SUPPLEMENTED.

The County of Tulsa State of Oklahoma, hereinafter referred to as the County, and the Oklahoma State Highway Commission, hereinafter referred to as the Highway Department, hereby agree as follows:

- 1. That the Highway Department will submit a project for the improvement of 6.75 miles of the Secondary highway from a point on SH 11 SE of Sperry, East to US 169, 1 mile north of Owasso known as County Road and to be designated as Oklahoma Federal-Aid Secondary Project No. S-319(1), and will recommend its approval by the Federal Works Agency, Public Roads Administration for construction with funds apportioned to the State under the Federal Highway Act as amended and supplemented, subject, however, to the condition that the County shall provide for its proper maintenance after completion of its improvement.
- 2. That said County hereby requests the Highway Department to submit the aforementioned project with recommendation that it be approved by its Federal Works Agency, Public Roads Administration and agrees that if such project is approved and constructed by the Highway Department and the Federal Works Agency, Public Roads Administration, it thereafter, at its own expense, will
