Chairman recognized members of the public wishing to speak regarding the agreement with McDonald, McCann, Metcalf and Carwile: Mike Workman, 5962 S. Pittsburg Ave., Tulsa, spoke against the use of public funds used in defense of the Sheriff to fight the Grand Jury Petition, noting that specific consent is required by District Attorney, not his office, reiterating that public funds should not be used to defend against public interest. Marq Lewis, 9134 E. Newton Place, Tulsa, Organizer of We the People petition, stated his position that his organization had to raise funds in order to fund the petition drive and that the Sheriff's defense process should not be on the backs of the taxpayers. Brad Broom, 2440 E. 22nd Place, Tulsa, recommended not using public funds for defense of the Sheriff because Oklahoma State law allows for reimbursement after the fact if the Grand Jury finds no wrong doing. No other members of the public who were present wished to speak.

Deputy Willis requested that Assistant District Attorney, Douglas Wilson speak to the issue: Wilson said that in a criminal proceeding, public money may not be used to retain legal counsel for a county employee. But according to Oklahoma law, a grand jury proceeding is not a criminal proceeding. It is a special proceeding for which public monies may be used to hire legal counsel to represent and advise the subject of the grand jury investigation. The District Attorney's Office believes that the Sheriff's contract with the McDonald, McCann law firm is a valid and proper contract. But the hiring of such an attorney is not carte blanch – that is, the attorney may not be paid with public funds to do anything and everything. Rather, such legal representation must be limited in scope to representing the proper interests of the Tulsa County Sheriff's Office. The contract in question attempts to address this issue with the following language:

"If outside counsel determines that the actions or omissions from which this litigation arises are reasonably determined to be the result of the fraudulent conduct or corruption by the employees/employee, outside counsel shall notify the County at once and this contract shall immediately terminate."

The District Attorney's Office believes such language sufficiently limits the scope of representation. This contract does not provide for legal representation of a county officer in a criminal proceeding. Rather, it provides legal representation for the Office of the Tulsa County Sheriff in this grand jury investigation. Because the contract is proper, the Board of County Commissioners' approval of such contract is likewise proper.
