Pursuantato recess heretofore taken, the Board of County Commissioners reconvened at the hour of 2:00 o'clock P. M. with all members present: J. B. Gray, Chairman, Curtis Greer and Claude W. Bailey, members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted:

Motion made by Mr. Greer, seconded by Mr. Bailey to refer bids received from Layman & Company of Tulsa, Oklahoma and Standard Paving Company of Tulsa, Oklahoma, to the County Engineer's Office for record. These bids cover the proposed improvement of McKinley Avenue Extension from North City Limits Sand Springs to Osage County Line, Project No.2-A, Surfacing and Improving. Layman and Co., Engineer's Estimate on Project 2-A in the amount of \$19,060.00; Standard Paving Company, Engineer's Estimate in the amount of \$18,905.25. All members voting in the affirmative, motion was by the Chairman declared carried.

M. June 3, 1946. Upon roll call, all members voting in the affirmative motion was by the Chairman declared carried.
