map and census mentioned in said application were left and remained subject to the examination at a convenient place within said territory in the manner and for the period prescribed by law, and the Board having been fully satisfied that all of the requirements of the law in such cases made and provided have been fully compled with, the Board concludes that an order should be made declaring that such territory, hereinafter described, shall, with the assent of the qualified voters thereof, as hereinafter provided, be and incorporated town by the name specified in the application aforesaid.

IT IS THEREFORE CONSIDERED and ORDERED by the Board of County Commissioners of Tulsa County, Oklahoma, that the applicants for the inforporation of the proposed town of Highland Park, Tulsa County, Oklahoma, embracing the territory described as Section 22, Township 19 North, Range 13 East, Tulsa County, Oklahoma, have fully complied with all of the provisions of the law in such cases made and provided; That such applicants duly caused an accurate survey and map to be made of the territory intended to be embraced within the limits of such town, which was made by a practical surveyor, and shows the courses and distances of the boundaries thereof and the quantity of land contained therein, the accuracy of which is duly verified in the affidavit of such surveyor; That such applicants also caused an accurate census to be taken of the resident population to be taken on a day nor more than thirty days previous to this date, which census exhibits the name of every heard of a family residing within such territory on such day, to-wit: May 18, 1946, and the number of persons then belonging to every family, which census was duly verified by the affidavit of the person taking the same; That such survey, map and census, when completed and verified as aforesaid was left at a convenient place within said territory for examination by those having an interest in such application, for a period of not less than thirty days; That due and ample notice of all of the foregoing was duly given by posting in many convenient places within said territory beginning thirty-one days prior to the date said application was presented to this Board.

IT IS FURTHER CONSIDERED and ORDERED by the Board of County Commissioners that said described territory shall be an incorporated town by the name of Highland Park, provided that a majority of the qualified voters assent thereto as hereinafter provided.

IT IS FURTHER CONSIDERED and ORDERED by the Board of County Commissioners that notice shall be given for a meeting of the qualified voters resident in proposed town to be held in a convenient place therein within one month from this date, to determine whether such territory shall be an incorporated town.

IT IS THEREFORE ORDERED that on the 8th day of July, 1946, in the double garage located on the premises of Frank Hickman, being numbered 5516 East 35th Street, Tulsa County, Oklahoma, within said territory, the same also being described as the double garage located on lot 3 block 9 of Yorkshire Estates, a subdivision within said territory, a meeting of the qualified voters resident in said proposed town be held, and the notice of such meeting shall be given for ten days prior thereto by publication in a newspaper published in the County of Tulsa, and by posting up copies of said notice not less than ten in number in the most public places in said proposed incorporated town.

IT IS FURTHER ORDERED that the said meeting on said date and place shall be held at 8:30 o'clock A.M. on said date and that the polls shall be opened at 9:00 in the forenoon of such day and shall be closed at 4:00 p. m. on such day, when they shall be closed, and that the voters at such meeting shall first proceed to the election of three inspectors, who after being duly chosen and qualified and one of their number elected Clerk, shall declare that the poll is now open and that they are now ready to receive the ballots of the voters, and thereupon qualified voters shall vote on ballots for or against the incorporation of Highland Park, Oklahoma.

IT IS FURTHER ORDERED that thereafter there shall be returned to the Board of County Commissioners proof of publication and proof of posting of the notice of said meeting and election and that the inspectors of such meeting shall make a statement under oath showing the whole mumber of ballots given at such meeting, showing the number having the work yes thereon, and the number having the word no thereon, duly verified by the affidavits of said inspectors, and that such return shall be made to this Board at their next session.
