Motion made by Commissioner Greer, seconded by Commissioner Gray, that the Cash Fund Estimate of Needs and request for Appropriation to the County Highway Cash Fund in the amount of \$17,296.88, be and the same is hereby approved and the Chairman is authorized to sign same and submit it to the Excise Board for consideration. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Gray, that the Cash Fund Estimate of needs and request for Appropriation to the County Highway Restricted Cash Fund in the amount of \$5,106.10, be and the same is hereby approved and the Chairman is authorized to sign same and submit it to the Excise Board for consideration. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motionmade by Commissioner Gray, seconded by Commissioner Greer, that Layman and Company, the lowest bidder, be awarded the contract for the Improving and Surfacing of Cincinnati Avenue from Mohawk Blvd. to 46th Street North, a distance of 2.062 miles, for a total amount of \$40.921.00. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried. Project 1-C.

Motion made by Commissioner Gray, seconded by Commissioner Greer, that the bids submitted by the Standard Faving Company and Layman & Company, on Project 1-B covering the improvement of 56th Street North, from Peoria to Lewis; Lewis Avenue - 56th Street North to 66th Street North, 66th Street North from Lewis Avenue to Peoria Avenue, a distance of 2.829 miles, be and the same are hereby rejected, and that Bidder's checks be returned to Contractors, and that a new estimate be prepared and submitted for approval and advertising. Both bids being above Engineer's estimate. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Bailey, seconded by Commissioner Greer, that Layman and Company, who submitted the lowest bid of \$42,400.15 on Project No. 3-A covering improvement of 21st Street from Yale Avenue to Memorial Drive, a distance of 2.004 miles, be awarded the contract. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the Proposals and Flans for the construction of a bridge across the Arkansas River near Jenks, Oklahoma, and the approaches thereto, prepared by the Fate Engineering Company and approved by the State Highway Commission - the Engineer's estimate being \$546,530.00, be and the same are hereby approved and the County Clerk is hereby authorized to advertise for bids to be received until nine o'clock A. M. July 8, 1946. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
