The Board of County Commissioners further finds and determines that said petition of Ruth Messamore and other is signed by a majority of the holders of titles to lands proposed to be included in the District, located outside of the limits of incorporated towns, and that said petition is in all respects legal and sufficient; and it is hereby further found and determined that due and legal notice, has been given to all persons interested in said improvement in the manner provided by law and in proper time for this hearing, and that said Water Improvement District, as amended herein, and the proposed improvements therein will be conducive to the public health and welfare of said proposed District, as amended, and that the probable cost of said improvement will not be excessive.

NOW, THEREFORE, BE IT AND IT HEREBY IS RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, that an election shall be and is hereby ordered to be held in the territory included within the proposed District, as herein amended, on the 16th day of July, 1946, from six o'clock a.m. to seven o'clock p.m. of said day, and that at said election there shall be submitted to the qualified electors therein, to be by them voted upon, the following proposition:

"Shall a Water Improvement District be established and organized pursuant to Chapter 7, Title 82, 0. S. 1941 (Paragraphs 771, et. seq.), including the following territory.

The following land situated in Tulsa and Creek Counties, Oklahoma, Namely: (Unless otherwise noted, the entire sub-division or the entire block of sub-division is included.) (Railroad rights-of-way are execulded.)

The portion of the land situated in Tulsa County, includes the lands as follows:

South Haven, except Lots 1 and 2, in Block 5, Lots 22 to 26, inclusive, in Block 25, of South Haven; Lots 17 to 32, inclusive, in Block 21, Freeland; Surburban; Opportunity Heights, except Lots 3, 5, 6, 7, 10 and 16 to 24, inclusive, in Block 3, and Lots 1, 2 and 3, in Block 5, and Lot 9; in Block 12, of Opportunity Heights; Bozarth Acres; Oakhurst Estates; New Taneha; East Addition to New Taneha, except Lots 1 to 6, inclusive, 1ve, 8 and 9, 11 to 15, inclusive, 19 and 20, 22 to 26, inclusive, 28 to 31, inclusive, in Block 14, and Lots 1 to 14, inclusive, and 25 to 31, inclusive, in Block 15, and Lots 1 to 9, inclusive, and 41 and 42 in Block 17, of East Addition to New Taneha; Taneha, Tulsa County, only Blocks 33, 34, 47, 48, A, B, 49 to 52, inclusive, 57 to 61, inclusive; North Taneha, only Blocks 39, 45 and 46; the balance of the land South and East of U.
