The monthly 2003 Sales Tax Overview Committee (STOC) meeting was called to order at 10:00 a.m. on September 17, 2009, by Tony Ringold, Chairman, at the Lecture Room of the Tulsa City-County Library.

- 1. A quorum was present. There were eight excused absences. Guests were Commissioner Karen Keith and Chief Deputy Mark Liotta. Others present were Kirby Crowe and Vallerie Davis, representatives of PMg Program Management Group.
- 2. The minutes of the August 20, 2009 meeting were approved.
- 3. The Chairman advised that he filed the requisite monthly report for August with the BOCC.
- 4. Vallerie Davis reported on the very serious auto accident involving Kevin Crosser, the Vice-Chairman. Mr. Crosser has been hospitalized in intensive care for several weeks but has recently been moved to a long-term acute care facility. She stated that PMg would be glad to coordinate donations if any member of the STOC desired to contribute.
- 5. Kirby Crowe presented comments on the August PMg Vision 2025 Report previously sent to the committee members. He advised that the Brady District has proposed a geothermal energy system for the district, to be funded by the George Kaiser Family Foundation, noting that the completed Broken Arrow NSU project has a geothermal system. He then reviewed Vision 2025 funding procedure for new members and reported on the status of several Vision 2025 projects, including the LaFortune Tennis Center; Route 66; Arkansas River Project; Mayo Building; First Street Lofts and Haikey Creek Mr. Crowe then presented the monthly financial report for August, 2009.
