Per section 7 of the Resolution authorizing and directing the establishment of a 2003 Sales Tax Overview Committee for Vision 2025, A.F. Ringold, Chairman, emailed the monthly report for the 2003 STOC, citing the following:

The monthly 2003 Sales Tax Overview Committee (STOC) meeting was called to order at 10:00 a.m. on October 15, 2009, by Tony Ringold, Chairman, at the LaFortune Community Center.

- 1. A quorum was present. There were seven excused absences. Guests were Terry Simonson, Tulsa County Director of Development and Governmental Affairs and Ella McKenzie, Executive Assistant to Commissioner Keith. Others present were Kirby Crowe and Vallerie Davis, representatives of PMg Program Management Group.
- 2. The minutes of the September 17, 2009 meeting were approved.
- 3. The Chairman advised that he filed the requisite monthly report for September with the BOCC.
- 4. Vallerie Davis reported on the condition of Kevin Crosser, the Vice-Chairman. Mr. Crosser was hospitalized in intensive care for several weeks but has been moved to the Meadowbrook facility. She stated that she and Cindy Pickell delivered gift cards, purchased with donations from the committee members, to the family and visited Kevin at Meadowbrook.
- 5. The Chairman noted the retirement of Suzanne Stewart from the Convention and Visitors Bureau and that he plans to invite her to the December meeting.
- 6. The Chairman suggested that the matter of nominations for officers for 2010 be deferred until next month, during which time he requested that committee members contact him with recommendations for nominations. There being no objection, the matter was deferred.
- 7. After considering whether to change the meeting format for 2010 to quarterly meetings, due to completion of many of the Vision 2025 projects, it was decided to continue the monthly meeting format.
- 8. Terry Simonson, representing Tulsa County, presented information about a 4-to-Fix II (2005) Proposition No. 1 that was one of four items on the ballot in November 2005 "collect sales tax for the purpose of funding Juvenile Justice Center and Courthouse Complex Renovations, improvements, furnishings and equipment..." Simonson explained that it has been determined by several qualified sources that it is no longer feasible to spend the \$2.5M from the 4-to-Fix II sales tax on the existing structure and location. Tulsa County is required to have a juvenile facility. The DA has advised the funds can be freed up to use toward building a new Juvenile Justice Facility once it is satisfied that it is not feasible to remodel the existing building at the existing site. Simonson asked for the support of the 2003 STOC, in an advisory capacity as a "citizen overview committee". Judge Fransein, County Engineer, Director of Building Operations, and an architect all toured and gave their expert opinions that it is not feasible to continue at the present location with the current

structure. If 2003 STOC committee is determined to be able to act in this capacity, according to its by-laws, it will be a fifth opinion toward the effort. Discussion ensued. Motion by Childers; seconded by Collins to authorize the STOC Chairman to appoint three members to meet with Simonson and, if needed, meet with the District Attorney. If it is determined that STOC has the authority to act in an oversight capacity, the Chairman will appoint four other STOC members to review/study and bring recommendation(s) to the November STOC meeting. It was suggested by Simonson to first ask the District Attorney to look at the STOC by-laws and determine if the group has the authority to act as oversight or, if the group desires to do so, if the by-laws need to be amended. Motion by Barnaby; seconded by Osteen to ask the District Attorney if the STOC Committee, through its by-laws, is authorized to act in this capacity. Motion carried unanimously.

- 9. Kirby Crowe presented comments on the September PMg Vision 2025 Report previously sent to the committee members. He reported on the status of several Vision 2025 projects, including OSU Tulsa; Morton Health Care; BOk Center litigation; LaFortune Tennis Center; Route 66; Haikey Creek; O'Brien Park; Mohawk Park; the East Meets West Bronze; and the American Indian Cultural Center. Mr. Crowe then presented the monthly financial report for September, 2009. He noted that current sales tax collections continue to be less than estimated about 9.5% less than last year. He concluded the financial report by announcing that Dr. John Piercey will present a revised sales tax forecast for the fiscal year beginning July 1, 2009 at the November meeting. Mr. Crowe then responded to questions from the committee members, after which his report was accepted.
- 10. Michael Gray presented a supplemental financial report for the Financial Review Sub-Committee. He stated that he had reviewed the summary compilation of the September PMg report and confirmed the statements made by Mr. Crowe.

The Chairman announced that the next meeting would be held on November 19, at the usual meeting place.
