Commissioner Smaligo also made a statement advising he did not agree that there was just cause for removal; but that Ms. Wright should take into consideration the statements made and work to be orderly, respectful, and more professional in the future. Commissioner Smaligo also stated Ms. Wright may also wish to consider stepping down from the position and offer it to someone who would be more effective in the operation of the Tulsa Metropolitan Area Planning Commission for District 2. Commissioner Perry stated he wanted to clarify what he had said earlier and that the reason he could not second the motion was that he also did not think Ms. Wright's actions quite justified removal from the position. However, if there had been a vote he would have abstained because he didn't want to put a stamp of approval on her unprofessional actions with a 'no' vote. The motion for Petition for Removal of Elizabeth Wright as District 2 Appointee, from Tulsa Metropolitan Area Planning Commission failed due to a lack of a second. (Clerk's Misc. File No. 216416)
