Mr. Rush had offered to build sidewalks to help get students from Oakhurst to their neighborhood school, Jane Addams. I made visits to the Dynaspan facility in Broken Arrow, and later with Ray Jordan, looked at another similar facility operating in the vicinity of the planned location. While I believe that Mr. Rush would run a first class operation, I had to consider the strong voice of the residents living near this corner. This development would require a dramatic change in zoning from Agriculture to Industrial Moderate. That leaps over Industrial Light

causing a potential domino effect of zoning changes along 65th West Avenue. There are close to 200 acres north of the strip that neighbors want to preserve as a buffer to their homes. I think it makes sense. There are ways to do industrial and residential so that you can accomplish both with as little impact as possible on nearby homes. That can be accomplished by leaving this buffer intact. I have been working since taking office to help the majority landowner in this area, Mr. David Polson, get a railroad crossing on the east side of his property. When he is successful, that effort will make it possible for traffic to exit away from industrial areas. It is my hope that we will all work together to get that crossing, which will allow for many jobs to fill in what is now vacant and unproductive land. Those jobs, with the buffer intact, will make for good neighbors. Acknowledging that Mr. Rush and the property owner Mr. Oakley have withdrawn their rezoning application, I do hope that Mr. Rush is able to find a location nearby that is already zoned industrial moderate. I firmly believe he will be a great addition and civic partner to that area. Commissioner Perry noted that he would have voted in favor of the appeal had it not been withdrawn because of job creation reasons and because of improvements that were going to be made in that intersection; the mitigating circumstances would have been taken care of by the applicant.
