Zoning Application Hearing and Possible Action - (Tulsa Metropolitan Area Planning Commission) - CZ-543 and Related PUD-867 - Applicant: Nathan Cross, Owner: Greenhill Properties, LLC - Requesting Rezone from present use Agricultural to Proposed use Commercial, AG to IM, a tract of 35 ± acres on the Northeast corner of Highway 169 and East 56th Street North. On meeting date May 17, 2023, TMAPC voted 4-3-1 to recommend that the County Commission Approve rezoning of 35 ± acres from AG to IM. The related PUD-867 from present Agricultural to Proposed Mining/ Commercial a tract of 225 ± acres. On meeting date of May 17, 2023 TMAPC voted 4-3-1 to recommend that the County Commission Approve rezoning of 225 ± acres from AG to PUD-867. Deferred from 11/6/2023

Motion made by Stan Sallee, seconded by James Rea, to enter into a public hearing at 9:39 a.m. Upon roll call, Yes - James Rea, Kelly Dunkerley, Stan Sallee. No - None. Abstain - None. Motion carried. Jay Hoyt, representing Tulsa Metropolitan Area Planning Commission (TMAPC), reviewed the zoning case.

In favor of approval, Nathan Cross, 2 W. 2nd Street, Suite 700, Tulsa, OK, spoke on behalf of the applicant, stating that noise and dust complaints should be made to the State Mining Commission and that the Tulsa County Board of County Commissioners have no administrative oversight over mines. He further stated that the State of Oklahoma has a robust system of oversight and that they investigate complaints and do periodic investigations that are not related to complaints. He asked Matt Richie, 1640 S. 104th E. Ave., Tulsa, OK, representing Sherwood Construction, to speak. Matt reiterated that the regulatory officers make monthly visits to the mine, and the Department of Mine Safety and Health and the Oklahoma Department of Environmental Quality also make quarterly visits. He stated that the dust complaints and the complaints about mud on the road have been resolved, both before any action was taken by the Department of Mines. He was asked about the thickness of the vein and the expected longevity of the mine. He responded that there are 7 1/2 million tons of limestone mined per year in Oklahoma in 3 quarries and that there are 10-30 years of reserves remaining.

Speaking against approval, Marsheila Prior, on behalf of her elderly parents, Clarence and Lorene Lamber, 6218 N. 129th E. Ave., Owasso, OK, reminded the members that her parents' property line is 450' from the proposed area and her brother's is 525' from the site. She stated that property owners were told it would be at least 10 years by the owners of this property before there would be mining on this new site. She also noted that there is a 5-year protection on the land due to eagle nests. She thanked Jim Rea for visiting the area last week, noting she mentioned that her parents' property abuts Bird Creek where there is a 50' drop due to erosion. She also stated that the housing developments between 66th and 76th Streets are \$350,000 homes and are only a mile to a mile and a half away in a dense housing area. She reiterated that they are not opposed to development, knowing that both the property owners and the County need to make money. She notes that this additional mining activity will adversely affect property values, reminding the Board that homeowners vote and are counting on elected officials to protect their property rights. She appealed to the Board not to approve both sites for mining.

Bret Lambert, 6718 N. 19th E. Ave., Owasso, OK spoke next. He asked Matt Richie again about how far below the surface the minerals lie. Matt Richie answered that it is 4-5' below the overburden and the vein is approximately 80' deep. Then Brett showed topographical maps indicating the elevations of the property and of Bird Creek, as well as pictures of recent flood events at those elevations, stating there is no way to contain the flood waters in this area. He also noted the continuous noise from rock crushers, the beeping of trucks backing up and horns/sirens blowing.

Pamela Kirk, 12107 E. 70th St., Owasso, spoke for herself and concerned neighbors, citing the zoning code which states that zoning changes are not to be detrimental to public health & safety and their general welfare. Based on the track record of existing quarries, damage to homes and dust, more mining would indeed be detrimental. Their only recourse is to complain to the Oklahoma Department of Mines, which has proved to be less than satisfactory at solving the problems. The dust problem has not been resolved. Flooding is also a great concern.

There were no others present who wished to speak. Motion made by Stan Sallee, seconded by James Rea, to close the public hearing at 10:20 a.m. Upon roll call, Yes - James Rea, Kelly Dunkerley, Stan Sallee. No - None. Abstain - None. Motion carried.

Commissioner Sallee asked when the mine would be exhausted, and what the plan is for the property after mining is complete. David Charney, 12150 E. 9th St. N., stated that the property owners are happy to stipulate via restrictive covenant that the second life of the area will never be a land fill. They mentioned that the City of Tulsa has approached them about possible water impoundment areas, or possible future uses for amenities and/or recreation. There is no other productive use for this property. The PUD has been done very thoughtfully and with good planning for the area.

Commissioner Dunkerly asked about the timing. David Charney responded that it is highly unlikely that mining will begin within the next 10 years. He does, however, expect commercial uses along the highway before that, reiterating that mining operations on these new sites is not imminent.

Chief Deputy James Rea mentioned that he did drive through the area last week and noted that this is not new, trending development for the area and noted that the growth of the area has not been impacted by the existing mines. He mentioned that this is where the natural resources are and cannot be moved to a different location. Would be in favor of a restrictive covenant stating the property will never be used for land fill into perpetuity.

David Cherny offered to iron out the details of further constraints/covenants, the timing and the planning.

Commissioner Sallee asked Jay Hoyt if the Commissioners have control over restrictive covenants for a PUD. Jay confirmed that the Board does have the ability to add covenants. Commissioner Sallee acknowledged that a restrictive covenant regarding landfill is one thing, but other land uses may be difficult to stipulate now. David Cherney agreed, stating that once mining is finished the area may not be fit for uses that are determined now.

David Cherney suggested that a motion to approve now could be contingent upon the composition of a restrictive covenant stating the property will never be used as landfill.

Commissioner Dunkerly preferred development of the language regarding impacts and landowners, allowing time for the landowners to adjust, noting that it is the applicant's responsibility to bring ideas & engineering forward for consideration.

Chief Deputy James Rea noted that he is willing to approve today with restrictive covenant.

Commissioner Dunkerley prefers to defer for one week to allow the applicant to develop the language and present it for approval.

Commissioner Sallee noted that many years ago the city of Owasso fought vigorously against mining in the area and lost in Federal Court. The courts upheld mining rights.

David Charney confirmed that they will draft conditions and send to the Commissioners for review prior to next Monday's meeting.
