Jay Hoyt, representing Tulsa Metropolitan Area Planning Commission, presented zoning case CZ-543 and related PUD-867. The Applicant, Nathan Cross, 2 W. 2nd Street, Tulsa, OK, spoke on behalf of the Owner, Greenhill Properties, LLC. David Charney, 12150 E. 96th St N., Owasso, also spoke in favor of the zoning. He provided aerial photos and spoke of his concern for thoughtful, overall development along that corridor. Of note is the addition of COSTCO and Amazon. Both companies have recently built there, and it is assumed that the experts they would have employed to research and survey the area prior to building would have advised against it if there were issues with the mines. He also pointed out that mining must occur where natural resources occur. A video interview with Randy Walker, President of White Industrial Seismology, Inc., was shown, discussing the State of Oklahoma limits for ground vibration and air pressure. He stated that transient dynamic vibration lasts only about a second and monitoring of mining operations to ensure that those limits are not exceeded are set to less than 50% of the State limit.

Marsheila Prior, 10965 Harreld Rd, Beggs, OK spoke on behalf of her elderly father, Clarence Lambert, 6218 N. 129th E. Ave., Owasso, OK, whose purchase of property pre-dates the mine's operation. Both her parents are in their 90s and are counting the value of their home to provide income to care for them for their lifetime. Bret Lambert, 6218 N. 129th E. Ave., Owasso, OK and Pamela Kirk, 12107 E. 70th St. N., Owasso, OK, also spoke opposing the addition of mining in that location. The issues surround the proximity of the operation to homes, the effects of blasting on their homes and the quality of their lives, the increased noise and effect of truck traffic and the silica dust produced by the mine and the adverse effects on Bird Creek. They also noted that they are not against development in the area and suggested that perhaps Anchor Stone and Greenhill Properties should jointly purchase property further to the north and west that is also rich with natural resources and not as close to existing housing.
