Know all Men by these Presents, That we, W. P. Moore
and Anna Moore his wife, for and in consideration
of the sum of One (\$1.00) DOLLARS,
in hand paid, the receipt of which is hereby acknowledged and confessed

do hereby grant, bargain, sell and convey unto the said Charlotte Epperson
and unto her heirs and assigns, forever, the following lands lying in the City of Tulsa Western
District of the Indian Territory, to-wit:

Lots One (1) and Two (2), in Block One Hundred and Twenty-one (121),
of the City of Tulsa, Indian Territory, according to the government plat
and survey thereof.

TO HAVE AND TO HOLD THE SAME unto the said Charlotte Epperson
and unto her heirs and assigns, forever, with all appurtenances thereunto belonging.
And hereby covenant with said Charlotte Epperson that we will forever
warrant and defend the title of said lands against all claims whatever. Subject to mortgage for
\$2000.00 to C. R. Leas

And I, Anna Moore wife of the said W. P. Moore for and
in consideration of the said sum of money, do hereby release and relinquish unto the said
Charlotte Epperson all my rights of dower and homestead in and to the said lands.
