

WARRANTY DEED—WITH RELINQUISHMENT OF DOWER.



Know all Men by these Presents, That we, Lila D. Lindsey
and L. W. Lindsey, her husband his wife, for and in consideration
of the sum of Eight Hundred ^{no.} 00 DOLLARS,
The receipt of the same being hereby acknowledged and is in hand paid by J. S. Crossley

do hereby grant, bargain, sell and convey unto the said J. S. Crossley
and unto his heirs and assigns, forever, the following lands lying in the Lindsey Addition to City of Tulsa, I.T. Western
District of the Indian Territory, to-wit:

Lot Ten (10) Block Ten (10) Lot Eight (8) Block Nine (9), in the second "Lindsey
Addition to the City of Tulsa, I.T." and according to the Recorded Plat thereof.

TO HAVE AND TO HOLD THE SAME unto the said J. S. Crossley
and unto his heirs and assigns, forever, with all appurtenances thereunto belonging.
And hereby covenant with said J. S. Crossley that they will forever
warrant and defend the title of said lands against all claims whatever.

And I, L. W. Lindsey, husband wife of the said Lila D. Lindsey for and
in consideration of the said sum of money, do hereby release and relinquish unto the said
J. S. Crossley all my rights of dower and homestead in and to the said lands.
