Know all Men by these Presents, That we, John O. Mitchell
and Alice M. Mitchell his wife, for and in consideration
of the sum of One hundred sixty six and $\frac{25}{100}$ DOLLARS,
The receipt of which is hereby acknowledged

do hereby grant, bargain, sell and convey unto the said Martin Reason
and unto his heirs and assigns, forever, the following lands lying in the Creek Nation Western
District of the Indian Territory, to-wit:

Lot number twenty (20) Block number twenty (20) West Tulsa
Indian Territory according to recorded plat thereof

TO HAVE AND TO HOLD THE SAME unto the said Martin Reason
and unto his heirs and assigns, forever, with all appurtenances thereunto belonging.

And hereby covenant with said Martin Reason that we will forever
warrant and defend the title of said lands against all claims whatever.

And I, Alice M. Mitchell wife of the said John O. Mitchell for and
in consideration of the said sum of money, do hereby release and relinquish unto the said
Martin Reason all my rights of dower and homestead in and to the said lands.
