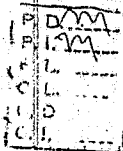

WARRANTY DEED—WITH RELINQUISHMENT OF DOWER.



Know all Men by these Presents, That we, John O. Mitchell
and Alice M. Mitchell his wife, for and in consideration
of the sum of One Hundred Fifty - 20/100 DOLLARS,
to us in hand paid by Fred Junk, the receipt of which is hereby acknowledged.

do hereby grant, bargain, sell and convey unto the said Fred Junk
and unto his heirs and assigns, forever, the following lands lying in the Town of West Tulsa, Creek Nation,
District of the Indian Territory, to-wit:

All of Lots Numbered Twenty One (21) and Twenty Two (22), in
Block Number Twenty Four (24), situate in West Tulsa, Creek Nation,
Indian Territory, according to the recorded plat filed thereof.

TO HAVE AND TO HOLD THE SAME unto the said Fred Junk
and unto his heirs and assigns, forever, with all appurtenances thereunto belonging.
And hereby covenant we with said Fred Junk that we will forever
warrant and defend the title of said lands against all claims whatever.

And I, Alice M. Mitchell wife of the said John O. Mitchell for and
in consideration of the said sum of money, do hereby release and relinquish unto the said
Fred Junk all my rights of dower and homestead in and to the said lands.
