Know all Men by these Presents, That we, Henry M. Price
and Victoria J. Price his wife, for and in consideration
of the sum of Four Hundred & Fifty no. DOLLARS,
The receipt of the same being hereby acknowledged and to us paid
by Mary E. Green

do hereby grant, bargain, sell and convey unto the said Mary E. Green
and unto her heirs and assigns, forever, the following lands lying in the Friend Addition to Tulsa, I. T. Western
District of the Indian Territory, to-wit:

Lot Five (5) Block Five (5) in the "Friend Addition" to the City of Tulsa
Incl. Ter. and according to the "Official Plat" and "Survey" of the said
Addition to Tulsa, Ind. Ter.

TO HAVE AND TO HOLD THE SAME unto the said Mary E. Green
and unto her heirs and assigns, forever, with all appurtenances thereunto belonging.
And hereby covenant with said Mary E. Green that they will forever
warrant and defend the title of said lands against all claims whatever.

And I, Victoria J. Price wife of the said Henry M. Price for and
in consideration of the said sum of money, do hereby release and relinquish unto the said
Mary E. Green all my rights of dower and homestead in and to the said lands.
