Know all Men by these Presents, That we, A. J. Mc Cartney
and Hattie Mc Cartney his wife, for and in consideration
of the sum of Eleven Hundred (1,000.00) DOLLARS,
the receipt whereof is hereby acknowledged

do hereby grant, bargain, sell and convey unto the said J. H. Robinson
and unto his heirs and assigns, forever, the following lands lying in the Creek Nation Western
District of the Indian Territory, to-wit:

Lot number 16 (b), in Block number Ninety-
nine (99), in the City of Tulsa, as shown by the
recorded plat thereof

TO HAVE AND TO HOLD THE SAME unto the said J. H. Robinson
and unto his heirs and assigns, forever, with all appurtenances thereunto belonging.

And hereby covenant with said J. H. Robinson that they will forever
warrant and defend the title of said lands against all claims whatever.

And I, Hattie Mc Cartney wife of the said A. J. Mc Cartney for and
in consideration of the said sum of money, do hereby release and relinquish unto the said J. H. Robinson

all my rights of dower and homestead in and to the said lands.
