WARRANTY DEED—WITH RELINQUISHMENT OF DOWER.

Know all Men by these Presents, That we, J. D. Hagler
and Margaret Hagler his wife, for and in consideration
of the sum of Seventeen Hundred (\$1700.00) DOLLARS,
to them in hand paid by J. P. Mc Carthy the
receipt whereof is hereby confessed and acknowledged

do hereby grant, bargain, sell and convey unto the said J. P. Mc Carthy
and unto his heirs and assigns, forever, the following lands lying in the Town of Tulsa Western
District of the Indian Territory, to-wit:

Lots numbered Ten and Eleven in Block Number
Two of the Bliss Addition to Tulsa according
to the recorded plat thereof

TO HAVE AND TO HOLD THE SAME unto the said J. P. Mc Carthy
and unto his heirs and assigns, forever, with all appurtenances thereunto belonging.

And hereby covenant with said J. P. Mc Carthy that they will forever
warrant and defend the title of said lands against all claims whatever.

And I, Margaret Hagler wife of the said J. D. Hagler for and
in consideration of the said sum of money, do hereby release and relinquish unto the said J. P. Mc Carthy
all my rights of dower and homestead in and to the said lands.
