

## WARRANTY DEED—WITH RELINQUISHMENT OF DOWER.



Know all Men by these Presents, That we, W. O. Dickenson  
and Stella M. Dickenson his wife, for and in consideration  
of the sum of Eight Hundred fifty DOLLARS,  
In hand paid by The Cherokee Company the receipt of which is hereby  
acknowledged

do hereby grant, bargain, sell and convey unto the said The Cherokee Company  
and unto its heirs and assigns, forever, the following lands lying in the Cherokee Nation Western  
District of the Indian Territory, to-wit:

North East quarter of South East quarter and North west quarter of South  
East quarter of South East quarter of Section Fifteen (15) Township Twenty (20)  
North Range Thirteen (13) East and an undivided one third interest in and to the  
West one half of South west quarter of Section fourteen (14) Township Twenty (20)  
North Range Thirteen (13) East

TO HAVE AND TO HOLD THE SAME unto the said The Cherokee Company  
and unto its heirs and assigns, forever, with all appurtenances thereunto belonging.

And hereby covenant & with said The Cherokee Company that they will forever  
warrant and defend the title of said lands against all claims whatever.

And I, Stella M. Dickenson wife of the said W. O. Dickenson for and  
in consideration of the said sum of money, do hereby release and relinquish unto the said  
The Cherokee Company all my rights of dower and homestead in and to the said lands.
