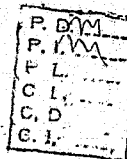

## WARRANTY DEED—WITH RELINQUISHMENT OF DOWER.



Know all Men by these Presents, That we, S. H. Williams  
and Bessie L. Williams his wife, for and in consideration  
of the sum of Fifty DOLLARS,  
paid by H. L. Eaton

do hereby grant, bargain, sell and convey unto the said H. L. Eaton  
and unto his heirs and assigns, forever, the following lands lying in the NE 1/4 of the Western  
District of the Indian Territory, to-wit: NW 1/4 and the West half (shown on  
the U. S. Survey as lots 1 & 2) of the NW 1/4 of Sec 31, T 19 N  
and Range 14 E, Creek Nation Western District of the Indian  
Territory, to-wit:

warrant and defend the title of said lands against all claims whatever.

And I, Bessie L. Williams wife of the said S. H. Williams for and  
in consideration of the said sum of money, do hereby release and relinquish unto the said H. L. Eaton  
all my rights of dower and homestead in and to the said lands.
