confessed

do hereby grant, bargain, sell and convey unto the said W. Lyle Dickey  
and unto his heirs and assigns, forever, the following lands lying in the City of Tulsa Western  
District of the Indian Territory, to-wit:

Lot Six (6) in Block Two (2) in Stansbery Addition to the City of Tulsa  
Indian Territory according to the recorded plat thereof
