Order of Court.

This cause came on to be heard on the report of the Commissioners George W. McAlpin, James H. Thomas and Charles Robertson Jr., who were appointed at the September setting of this Court to make a partition of certain real property owned by John S. Burgess during his life time, and described as Lots 4, 5, and South 20 ft of Lot 3, in Block 3, town of North Leesha, Indian Territory. Said commissioners' report being filed in open court, and it appearing from said commissioners' report to the satisfaction of the Court that said property can be divided with fairness to all parties interested therein, and it appearing from said report that said commissioners have recommended that the property be divided as follows:

The North 66- $\frac{2}{3}$ feet of said lots be given to Carrie U. Hansen, the central 66- $\frac{2}{3}$ feet to Daniel W. Burgess, and the South 66- $\frac{2}{3}$ feet to Alma V. Gipson.

And it further appearing to the satisfaction of the Court from the statement of agreed facts filed by the attorneys for Carrie U. Hansen et al., and Daniel W. Burgess et al that Carrie U. Hansen, Alma V. Gipson and Daniel W. Burgess are the only living children of John S. Burgess, deceased, and are therefore the only heirs at law to the estate of John S. Burgess, deceased; and it appearing further to the Court from the said agreed statement of facts that the widow of John S. Burgess, deceased, has relinquished her dower interest in this property to Carrie U. Hansen, Alma V. Gipson and Daniel W. Burgess by Quit Claim deed.

It is therefore ordered, adjudged and decreed that Lots 4, 5 and the south 20 feet of lot 3 in Block 3 in the town of Leesha, Indian Territory, be partitioned and divided between Alma V. Gipson, Carrie U. Hansen and Daniel W. Burgess as follows, to wit:

To Carrie U. Hansen the North 66- $\frac{2}{3}$ feet of Lot 4 and the south 20 feet of Lot 3; to Daniel W. Burgess the north 23- $\frac{1}{3}$ feet of Lot 5 and the south 43- $\frac{2}{3}$ feet of Lot 4; and to Alma V. Gipson the South 66- $\frac{2}{3}$ feet of lot 5, all in block 3, town of North Leesha, Indian Territory.

And it is further ordered, adjudged and decreed that the title to this property shall rest in them as divided.
