Warranty Deed.

Shew all Men by These Presents: That the Aleuma Townsite Company, a corporation, organized and existing under the laws of the United States in force in the Indian Territory, in consideration of seventy five (\$75) Dollars, each in hand, paid to it by F. P. Hannifin the receipt whereof is hereby acknowledged, do hereby give, grant, bargain, sell and convey unto F. P. Hannifin all the following described parcel of land situate in the town of Aleuma, Creek Nation, Indian Territory (according to the survey and plat of town embraced in the land described as the East Half of the Southwest Quarter and Lot Three (3) of Section Thirty (30) Township Nineteen (19) Range Fourteen (14) East according to the United States survey) said parcel of land being known and designated upon the plat thereof as Lots number 6, 7, 8, 9, + 10, Block number 27.

To Have and to Hold the aforegranted premises unto the said F. P. Hannifin and his heirs in fee simple forever, and the said Aleuma Townsite Company, for itself, its successors and assigns, covenants with the said F. P. Hannifin and his heirs and assigns that it is lawfully seized in fee of the aforegranted premises, and that the same are free from all encumbrances; that it has a good right to sell and convey the same to said F. P. Hannifin as aforesaid, and that it will, and its successors, shall warrant and defend the same to the said F. P. Hannifin and his heirs and assigns forever against the lawful claims and demands of all persons.
