Rental Contract.

This agreement made and entered into this 23 day of Jan., 1907, by and between Hannah M. Davis, ^{John W. Davis} Guardian; Jael M. Davis, Theodore Davis, of Vera d. t. party of the first part, and L. W. Matthews, of Vera, d. t. party of the second part.

The said party of the second part, for the use of the said land, agrees to pay to the party of the first part, as rent, Twenty-Five Dollars for 5 Five years the term of this contract, payable as follows; Twenty five dollars, cash in hand paid by party of the second part, receipt of which is hereby acknowledged and improvements as follows; Two dwelling houses, (two room house with a room on the second floor) Two small barns, two wells; also to fence in a yard around each house with pickets of boards; also to build a fence on the east line of fall's place - The two houses are to be are to be sided up and down with common lumber and to have the joints battled and the first story to be plastered, The houses are to be 14 ft. x 24 ft.

The said party of the first part agree that after the expiration of her guardianship of Jael Davis and Theodore Davis that she will procure from said minors the unexpired time this lease covers; all of the fencing are to be left in as good repair at the expiration of this lease, so they are at the time this instrument takes effect.
