Deed. General Warranty.

This Indenture, made this 13th day of February A.D. 1907, Between The Cragin Lumber Company of Kansas (a corporation) of the first part and Rock Island Lumber & Coal Company, of the second part.

Witnesseth, the said party of the first part, in consideration of the sum of Sixty Two Hundred Eighty six (\$62 86.27) and $\frac{2}{10}$ Dollars, the receipt whereof is hereby acknowledged, date by these presents grant, bargain, sell and convey unto said party of the second part, its successors and assigns, all of the following described Real Estate, situated in the Creek Nation, Indian Territory, to-wit: Lots Seven (7), Eight (8), Nine (9) and Ten (10) in Block Number Twenty-eight (28), in Midland Addition to the Town of Bixby, Indian Territory, as shown by the plat on file in the office of the Clerk of the United States Court at Sapulpa, Indian Territory. Lots One (1), Two (2), Three (3) Four (4) Five (5) and Six (6) in Block Number 28, in Midland Addition to the Town of Bixby, Indian Territory, as shown by the plat on file in the office of the Clerk of the United States Court at Sapulpa, Indian Territory.

To have and to hold the same, together with all and singular the tenements hereditaments and appurtenances thereto belonging or in any wise appertaining forever.

And said The Cragin Lumber Company, party of the first part, for itself, its successors and assigns doth hereby covenant, promise and agree to and with said party of the second part, that at the delivery of these presents it is lawfully seized in its own right of an absolute and indefeasible estate of inheritance, in fee simple, of and in all and singular the above granted and described premises, with the appurtenances; that the same are free, clear, discharged and unencumbered of and from all former and other grants, titles, charges, tennants, judgments, leases, encumbrances and incumbrances, of what nature or kind soever, and that it will warrant and forever defend the same unto said party of the second part its successors and assigns, against whomsoever, lawfully claiming or to claim the same.
