General Warranty Deed

(With Relinquishment of Dower)

This Indenture, made and entered into this 19th day of April (1905) one thousand, nine hundred and five, by and between Mariah Martin and Isaac Martin, her husband, Ellen Maberry and Thomas Maberry, her husband, Minnie Shepard, a single woman, and Gunter Shepard, a single woman, the sole heirs of Simon Shepard, deceased, parties of the first part, of Tahlequah and Fort Gibson, A.T. and J. Warren Reed of Muskogee, Indian Territory, party of the second part.

Witnesseth, That the said parties of the first part, for and in consideration of the sum of One Dollar, in hand paid and other good and valuable considerations in hand paid the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto the said party of the second part, the following described real estate and premises situate in the Cherokee Nation, and within the limits of the Narbonne District, Indian Territory, to-wit: All of the Homestead held on by our brother Simon Shepard (now deceased) as a Cherokee Freedman, and which Homestead by the death of said Simon Shepard has descended to us as his sole and only surviving heirs, and more particularly described as follows, to-wit: The south half of the south west quarter, and the north west quarter of the south west quarter of section Twenty-nine (29) Township Twenty two (22) Range (14) fourteen East containing thirty acres more or less, together with all the improvements thereon, and the appurtenances and immunitiess thereto belonging, or in any wise appertaining thereto.

To Have and To Hold the aforesigned premises to the said J. Warren Reed and his heirs and successors, in fee simple forever; And we, the said Mariah Martin, Ellen Maberry and Minnie Shepard, and Gunter Shepard, the sister and sole heirs of said Simon Shepard for ourselves and our heirs, executors and administrators do covenant with the said J. Warren Reed, and his heirs, successors and assigns, that we are recognized enrolled and approved Freedman Citizens of the Cherokee Nation, and not of Indian blood or Indian descent; that we are lawfully seized in fee of the aforesigned premises; that they are free from all incumbrances; that we have good right to sell and convey the same to the said J. Warren Reed, aforesaid, and that we will and our successors and heirs, executors and administrators shall warrant and defend the same to the said J. Warren Reed, and his heirs, successors and assigns forever against the lawful claims and demands of all persons.
