Rental Contract.

This Indenture, made and entered into on this 11th day of February, A.D. 1907, by and between Isaac Johnson & Nicy Johnson, his wife of Broken Arrow, Ind. Ltr. parties of the first part, and Frank L. Haymes, of Broken Arrow, Ind. Ltr. party of the second part.

Witnesseth: That the said parties of the first part for and in consideration of the covenants of the said party of the second part, hereinafter set forth, do by these presents lease to said party of the second part, and his assigns for agricultural purposes only, the following described tract of land, lying and being within the Creek Nation and within the Indian Territory, to wit: The East Half of the North West Quarter, of Section Twelve (12) Township Eighteen (18) North, and Range Fourteen (14) East. Being the East Half of the allotment of the said Isaac Johnson and containing 80 acres, more or less for the full term of Five years from date thereof. And the said party of the second part, in consideration of said premises as above set forth, covenants and agrees with the party of the first part to pay said parties of the first part as rental of the same the sum of One Hundred Dollars (\$100.00) payable as follows, to-wit: All payable in advance, receipt whereof is hereby acknowledged. This lease is subject to a lease executed by first party to Daniel Welch, in the fall of 1905, which lease was for five years from date thereof. The said party of the second part further covenants that he will, at expiration of this contract deliver to party of the first part the premises herein, together with the improvement thereon in good condition usual wear and avoidable accidents excepted. And upon this failure to comply with the conditions of this contract as to payment of rents, and improvements, this contract shall become void at option of the parties of the first part.

It is mutually agreed that the covenants herein contained shall extend to and be binding upon the heirs, executors, administrators and assigns of the parties to this contract.
