Newberry, his wife of the County of Tulsa, Creek Nation, Indian Territory,
do hereby certify that the sum of Eight thousand and ten
(\$8010.00) Dollars to them each in hand paid by (Franklin Miller, Anderson,
the receipt of which is hereby accepted and acknowledged as fully
paid, bargain, sold and convey unto the said (Franklin Miller, Anderson,
and unto his heirs and assigns forever the following land lying
and being in the Western District, Creek Nation, Indian Territory
