Power of Attorney.

Know All Men By These Presents; That, I, Malcom Murray of the Cherokee Nation, have this day made and appointed A. B. Butts of Muskogee, Indian Territory, my lawful agent and Attorney in fact to act for me in my name, place and stead in the transaction of the following business, that is to say, to sell, to lease, to let, rent and otherwise dispose of my lands in the Cherokee Nation, which have been allotted to me by the authority of the United States Government; which land is described as follows,

to wit: The South West $\frac{1}{4}$ of North East $\frac{1}{4}$ and North West $\frac{1}{4}$ of South East $\frac{1}{4}$ of Section 19, Township 22, Range 13, East and the North East $\frac{1}{4}$ of South East $\frac{1}{4}$ of North West $\frac{1}{4}$ of Section 27, Township 19, Range 23 East; The said A. B. Butts shall have the right to lease the above described land for Gas and Oil purposes, to take personal charge of all my papers of or pertaining to the above described land; to take charge of all my personal property; to collect all money due me and all

money that may come due me from the United States Government and the Cherokee Nation. Power is hereby conferred upon A. B. Butts to collect all money due on contract previously entered into, by me or by my agent.

The said A. B. Butts by these presents is authorized to sign my name to any and all instruments of writing necessary to the consummation of the business aforesaid and to do and perform any and all acts and things necessary to the accomplishment of the same as I could lawfully do if personally present and acting. And I hereby ratify and confirm all that my said attorney may lawfully do relative to the business aforesaid.

Now, the said Malcom Murray by these presents acknowledges himself indebted to the said A. B. Butts for services rendered as attorney; therefore this Power of Attorney is given to the said A. B. Butts as collateral security for the said indebtedness, and all money collected, and all property acquired (both real and personal) under this Power of Attorney shall be applied to the said indebtedness.

All former Powers of Attorney relative to said business so intrusted to my said agent are hereby revoked, and this Power of attorney is irrevocable.
