For \$ 34.00 per annum as follows:

\$ 34.00 in advance, receipt whereof is hereby acknowledged,

and \$ 0.00 first day of Jan, 1907,

and if grain or part of the crop, paid as follows: 1-00, and of cotton 00 and if any improvements, made as follows:

It is understood and agreed that the party of the second part will pay said party of the first part a rental of \$34.00 per annum during the term of this contract, payable as follows: Two hundred fifty Dollars cash in advance, receipt of which is hereby acknowledged ninety four. Dollars on December 1, 1907, Part of the first year to build a 14 feet x 16 feet house before March 1, 1907 on this land and build a six house stable before March 1, 1907.
