WITNESSETH: That for and in consideration of the agreement hereinabove made by the party of the second part, that the party of the first part he and by three pieces due date and let his heirs of the first part he this day rented unto the party of the second part, his executors, administrators and assigns, for agricultural purposes, for the term of five years, from the 21<sup>st</sup> day of February 1907, the following described farm or parcel of land, to wit: 1/2 of 1/4 of N.W. 1/4 of

Section 26 Township 21 N. Range 14 E. I. N.

For \$ per annum as follows:  
\$ in advance, receipt whereof is hereby acknowledged,  
and \$ first day of 1907;

and if grain or part of the crop, paid as follows: 1- and of cotton 1- and if any improvements, made as follows:

It is understood and agreed that the party of the second part shall pay said party of the first part rental as follows, to wit:

The sum of two hundred (200.00) dollars for said term, all of which amount is paid in advance by said party of the second part, the receipt of which is hereby acknowledged.
