

## RENTAL CONTRACT.

This Agreement, Made and entered into this the 16 day of March, 1907, by and between

WITNESSETH: That for and in consideration of the agreement hereinabove named by the party of the second part, that the party of the first part do hereby rent unto the party of the second part, the for agricultural and grazing purposes, for the term of five years, from the 1st day of April, 1907,

the following described farm or parcel of land, to wit: 30 acres of surplus land follows:

SW 1/4 of NE 1/4 and N E 1/4 of SW 1/4 of NE 1/4 of Section 34 Township 22 N, Range 14 E, and 30 acres of homestead as follows: NW 1/4 of SW 1/4 of NE 1/4 and N W 1/4 of SW 1/4 of NE 1/4 of Section 34, Township 22 N, Range 14 E.

It is understood and agreed that the party of the second part will pay said party of the first part a rental of \$20.00 per annum during the term of this contract, payable as follows: \$2.00 in each and \$20.00 on the 1st days of April 1908, 1909, 1910 and 1911, receipt of said each payment being hereby acknowledged.
