

WARRANTY DEED—With Relinquishment of Power and Homestead.

This Indenture, Made this 22 day of July A. D. 1907, between
David L. Sleeper and Hella B. Sleeper his wife,
Fulsa T. I. in the Western District of the Indian Territory, part 1st of the first part, and
J. R. Smith
 of — part 4 of the second part,

WITNESSETH, That whereas the said part 1st of the first part, for and in consideration of the sum of Four hundred & twenty five (\$425.00) DOLLARS,

to them in hand paid by said J. R. Smith
 the receipt whereof is hereby duly acknowledged, he sold, and by these presents do hereby Give, Grant, Bargain, Sell, Convey and
 Confirm unto the said part 4 of the second part, h. M. heirs and assigns, in fee simple, forever, all that tract or parcel of land, situated
 in the Town of Fulsa Creek Nation, Western District of the
 Indian Territory, according to the United States Survey and official plat thereof, as made by the
 Townsite Commission, and approved by the Secretary of the Interior of the United States, bound and described as follows, to-wit:

Lots three (3) and four (4) in Block five (5) of Richards
subdivision of said Block five (5) of Lindsay's Addition
to the said City of Fulsa Indian Territory.

Together with all and singular the privileges, improvements, tenements, hereditaments and appurtenances thereunto belonging or in
 anywise appertaining, with all the estate, title and interest of said part — of the first part therein.

The said part 1st grantor hereby covenant with the said part 4 grantee that the y. are the lawful owners of the said parcel
 or tract of land; that the title thereof is in them; that the y. are seized of a good and indefeasible estate of inheritance
 therein, and have a lawful right to sell and convey the same; that there are no liens or mortgages on said property of any kind or
 nature whatsoever.

And the said part 1st of the first part hereby covenant and agree with the said part 4 of the second part, that the y. will, and
their heirs, executors and administrators shall, forever warrant and defend the title to the said lands against all lawful and
 equitable claims and demands whatsoever.

And I, Hella B. Sleeper wife of the said David L. Sleeper
 for and in consideration of the said sum of money, and for divers and other good and valuable considerations, do hereby release, relinquish
 and quit-claim unto the said J. R. Smith his heirs and assigns, all my rights, claim
 or dower, and my homestead or possibility of dower or homestead, in and to the aforescribed premises.
