This Agreement, Made and entered into this 20th day of Aug 1907 by and between

 to deliver to said Co. T East a warrant Deed to the
 west half of the north west quarter and the north
 east of the south east quarter defined in section 27 twenty
 seven Township 27 Range 13 thirteenth east of double
 the aforesaid land as made by the Davis Commission 1907
 above witnesseth, That for and in consideration of the covenants and agreements hereinafter made by the part of the second part, the

 do demise and let to the part of the second part his heirs and assigns, for purposes, for the term of
 and agreeable
 Five (5) years from the 20th day of Aug 1907 the following
 described parcels of land:
