## WARRANTY DEED

WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we John O Mitchell and Alice M Mitchell  
 his wife, for and in consideration of the sum of Fifty and no DOLLARS,  
to us in land paid by Minnie E Redman the receipt  
of which is hereby acknowledged do hereby grant,  
 bargain, sell and convey unto said Minnie E Redman and unto her heirs and assigns forever, the following  
 lands lying in the Creek Nation Western District of the Indian Territory, to wit:  
all of Lot numbered One in Block numbered  
fourteen (14) situated in the town of West Tulsa  
Creek Nation Indian Territory according to the  
official plat thereof

To have and to hold the same unto the said Minnie E Redman and unto her heirs and as-  
 signs forever, with all appurtenances thereunto belonging.

And hereby covenant with said Minnie E Redman that she will forever warrant and defend the  
 title of said lands against all claims whatever.

And I, Alice E Mitchell wife of the said John O Mitchell for and in consideration of the said sum of  
 money, do hereby release and relinquish unto the said Minnie E Redman all rights of dower and homestead in and to the said lands.
