KNOW ALL MEN BY THESE PRESENTS.

That we W E Campbell and Emily M. Campbell  
 his wife, for and in consideration of the sum of Four Hundred in hand paid DOLLARS,  
W L Kennamer receipt of which is hereby acknowledged and  
 confessed do hereby grant,  
 bargain, sell and convey unto said W L Kennamer and unto his heirs and assigns forever, the following

lands lying in the Western Western District of the Indian Territory, to wit:

Lot fourteen (14) in Block two (2) in the George  
Perryman addition to the City of Muskogee Indian  
Territory, according to the recorded plat thereof.

To have and to hold the same unto the said W L Kennamer and unto his heirs and as-  
 signs forever, with all appurtenances thereunto belonging.

And hereby covenant with said W L Kennamer that we will forever warrant and defend the  
 title of said lands against all claims whatever.

And I, Emily M Campbell wife of the said W E Campbell for and in consideration of the said sum of  
 money, do hereby release and relinquish unto the said W L Kennamer all rights of dower and homestead in and to the said lands.
