WARRANTY DEED

WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we S. H. Williams and Bessie L. Williams
 his wife, for and in consideration of the sum of Twelve — $\frac{50}{100}$ DOLLARS,
to be paid by Henry Hornacker

do hereby grant,
 bargain, sell and convey unto said Henry Hornacker and unto his heirs and assigns forever, the following
 lands lying in the N. E. 1/4 of the NW 1/4 and the West half (shown on the U.S.
Survey as lots 1 & 2) of the NW 1/4 of Sec 31, T 19 N and
Range 14 E, Creek Nation, Western District of the Indian
Territory to-wit:

Lot 13 No. Thirteen block 15 No. fifteen
in Valley City
 To have and to hold the same unto the said Henry Hornacker and unto his heirs and as-
 signs forever, with all appurtenances thereunto belonging.

And hereby covenant we with said Henry Hornacker that we will forever warrant and defend the
 title of said lands against all claims whatever.

And I, Bessie L. Williams, wife of the said S. H. Williams for and in consideration of the said sum of
 money, do hereby release and relinquish unto the said Henry Hornacker all rights of dower and homestead in and to the said lands.
