WARRANTY DEED

WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we S. H. Williams and Bessie L. Williams
 his wife, for and in consideration of the sum of Twelve + 50/100 DOLLARS,
to me paid by E. B. Scott

do hereby grant,
 bargain, sell and convey unto said E. B. Scott and unto his heirs and assigns forever, the following
 lands lying in the N.E. 1/4 of the NW 1/4 and the West half C shown on the U. S.
Survey as lots 1 & 2 of the N.W. 1/4 of Sec. 2, T19N and Range
14E, Creek Nation Western District of the Indian
Territory, to-wit:

Lot 18 & 19, Block 5 N.C. Five
in Valley City

To have and to hold the same unto the said E. B. Scott and unto his heirs and as-
 signs forever, with all appurtenances thereunto belonging.

And hereby covenant we with said E. B. Scott that we will forever warrant and defend the
 title of said lands against all claims whatever.

And I, Bessie L. Williams, wife of the said S. H. Williams for and in consideration of the said sum of
 money, do hereby release and relinquish unto the said E. B. Scott all rights of dower and homestead in and to the said lands.
