This Indenture, made and entered into this 2<sup>nd</sup> day of June, one thousand, nine hundred and six, by and between Joseph B. Powell and Kate C. Powell of Clark, Mo. Justice of the first part and John W. McCracken of Broken Arrow, Okl. Justice of the second part.

Witnesseth: That the said parties of the first part, for and in consideration of the sum of Nine Hundred \$ Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party of the second, <sup>part,</sup> the following described real estate and premises situate in the Creek Nation, and within the limits of the Indian Territory, vizt.: Lots number sixteen, seventeen and eighteen in Block number twenty seven in the town of Broken Arrow in Creek Nation, Indian Territory, together with all the improvements thereon, and the fixtures and immovable burdens belonging or in any wise appertaining, and warrant the title to the same.

And I, Kate C. Powell wife of the said Joseph B. Powell for and in consideration of the said sum of money, do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said party of the second part, his heirs, executors, administrators and assigns forever.
