General Warranty Deed.

This Indenture, made and entered into this second day of August, one thousand nine hundred and six by and between Lottie Bussey and S. M. Bussey (his husband) of Collinsville, D. T. parties of the first part, and William B. Rose of Collinsville, D. T. party of the second part,

Witnesseth: That the said parties of the first part, for and in consideration of the sum of One hundred dollars, in hand paid thereof of which is hereby acknowledged, do hereby grant, bargain, sell, convey and convey firm unto said party of the second part the following described real estate and premises situated in Cherokee nation, and within the limits of the Indian Territory to-wit: One full and equal one-seventh ($\frac{1}{7}$) undivided interest in and to the following described tract of lands to-wit: - This with $\frac{1}{2}$ of S. W. $\frac{1}{4}$ of N. E. $\frac{1}{4}$ and the N. W. $\frac{1}{4}$ of S. E. $\frac{1}{4}$ of Section eight (8) Township Twenty-one (21) North Range fourteen (14) East of the Indian Meridian. Also the N. E. $\frac{1}{4}$ of N. W. $\frac{1}{4}$ of N. E. $\frac{1}{4}$ of Section thirteen (13) Township Twenty-one (21) Range fourteen East of the Indian Meridian, together with all the improvements thereon, and the appurtenances and immunities thereto belonging or in any wise appertaining and warrant the title to the same.

To have and to hold the said lands unto the said party of the second part his heirs, executors, administrators and assigns forever. In Witness Whereof, The said parties of the first part have hereunto set their hands and seals the day and year first above written.
