Warranty Deed.

Know All Men By These Presents:

That I, Katherine Leaver, of the city of Chillicothe, County of Livingston, State of Missouri; for and in consideration of the sum of One No/100 Dollars (and other considerations thereunto mentioned), to me in hand paid by Sarah W. Crellin, the receipt whereof is hereby acknowledged duly received, bargained and sold, and do by these presents grant, bargain and sell and convey . . . unto the said Sarah W. Crellin and unto her heirs and assigns, executors and administrators forever the following described real estate, situated, lying and being in Western District, Creek Nation, Indian Territory: Lots numbered Two (2) and Three (3) of Block numbered Two hundred and four (4) in the town of Tulsa, Indian Territory, according to the survey and plat thereof.

With all the privileges, appurtenances and improvements thereon situated, affixing and thenceunto belonging, To Have And To Hold the same unto the said Sarah W. Crellin, her heirs and assigns, executors or administrators forever. And I, the said Katherine Leaver, for myself, my heirs, executors, administrators do covenant with the said Sarah W. Crellin, her heirs and assigns, executors or administrators, that I do lawfully reign in fee simple of the aforesaid granted premises; that they are free from all incumbrance; that I have good and lawful right to convey the same as is herein done; that I will and my heirs executors and administrators shall, forever warrant and defend the title to the same, as to any and all acts done by me, to the quiet enjoyment of the said Sarah W. Crellin, her heirs and assigns, executors or administrators against all lawful claims or demands of all persons whomever claiming by through or under me.
