Warranty Deed.

This Indenture, Made and entered into this 27th day of August, 1906, by and between Willie W. Bridges, and his wife Della Bridges of Enigma, O. I., parties of the first part, and George T. Winkler, of Leaven, Kansas, party of the second part, Witnesseth: That the said parties, of the first part, for and in consideration of the sum of \$50 and 00/100 Dollars in hand paid, the receipt of which is hereby acknowledged, doth hereby grant, buy, sell, convey and confer unto the said party of the second part, the following described real property, lying and situated in the incorporated town of Collinsville, Cherokee Nation, Indian Territory, to-wit: All of lot Eight (8), Block Forty (40) together with the tenements, hereditaments and appurtenances therunto belonging or in any wise appertaining.

To Have and To Hold the same unto the said second party his heirs and assigns, forever. And the said first parties hereby covenants and agrees with the said second party, that at the execution and delivery hereof the first parties are the owners of the above described premises free and clear of any incumbrances whatever, and will forever warrant and defend the title to the said real property in and to the second party, his heirs and assigns, against all claims or acts of the first parties and those of all persons claiming by, through or under him.
