Warranty deed.

Know all Men By These Presents, That we, John R. Greenlee and Ida M. Greenlee, his wife, for and in consideration of the sum of Five thousand dollars (\$5,000.00), to us paid by George C. Priestly, do hereby grant, bargain, sell and convey to the said George C. Priestly and unto his heirs and assigns forever the following lands, lying in the Fourth Recording District, of the Indian Territory, to-wit:

Lots One, Two, Three, Four, Five, Six, Seven, Eight, Nine, Ten, Eleven, Twelve, Thirteen, Fourteen and Fifteen of Block One (1).

Lots One, Two, Three, Four, Five, Six, Seven, Eight, Nine, Ten, Eleven, Twelve, Thirteen, Fourteen, Fifteen, Sixteen, Seventeen, Eighteen, Nineteen, Twenty-one, Twenty-two, Twenty-three and Twenty-four, of Block Two, (2).

Lots One, Two, Five, Six and Seven and Eight of Block Three, (3).

All of Block Four (4).

All of Block Five (5) embracing Lots One to Twenty-four (24) inclusive:
