Know All Men By These Presents: That we, George C. Priestley and Lulu R. Priestley, his wife, of Bartlesville, Indian Territory, for and in consideration of the sum of Five Thousand Dollars (\$5000.00) to us paid by Avasso Gas Company, do hereby grant, bargain, sell and convey to the said Avasso Gas Company and unto its executors and assigns forever, the following lands, lying in the Fourth Recording District of the Indian Territory, to wit:

Lots One, Two, Three, Four, Five, Six, Seven, Eight, Nine, Ten, Eleven, Twelve, Thirteen, Fourteen and Fifteen of Block One (1).

Lots One, Two, Three, Four, Five, Six, Seven, Eight, Nine, Ten, Eleven, Twelve, Thirteen, Fourteen, Fifteen, Sixteen, Seventeen, Eighteen, Nineteen, Twenty-one, Twenty-two, Twenty-three, and Twenty-four of Block Two (2).

Lots One, Two, Five, Six and Seven and Eight of Block Three (3).

All of Block Four (4).

All of Block Five (5), embracing Lots One to Twenty-four inclusive.
