## Deed of Release

That the First National Bank of Tulsa, Indian Territory,  
for and in consideration of the sum of One Dollar (\$1.00) to be  
paid, does hereby grant, bargains, sell and convey unto Charney  
& Oliver and unto his heirs and assigns forever the following  
described real estate, to wit:

Lot Five (5) in Block Fourteen (14); Lots Three, Four and Five (3, 4 & 5) in Block Sixty (60), and Twenty-five (25) ft. by Ninety-two (92) ft., beginning Seventy-five (75) ft. North of the N.E. corner of Lot Two (2) in Block Sixty (60), thence S.W. paralleling the side of said blocks for Ninety-two (92) ft., thence N.W. paralleling Main St. Seventy-five (75) ft., thence Ninety-two (92) ft. N.E., thence Seventy-five (75) ft. S.E. to point of beginning all in the original town of Tulsa, Indian Territory.
